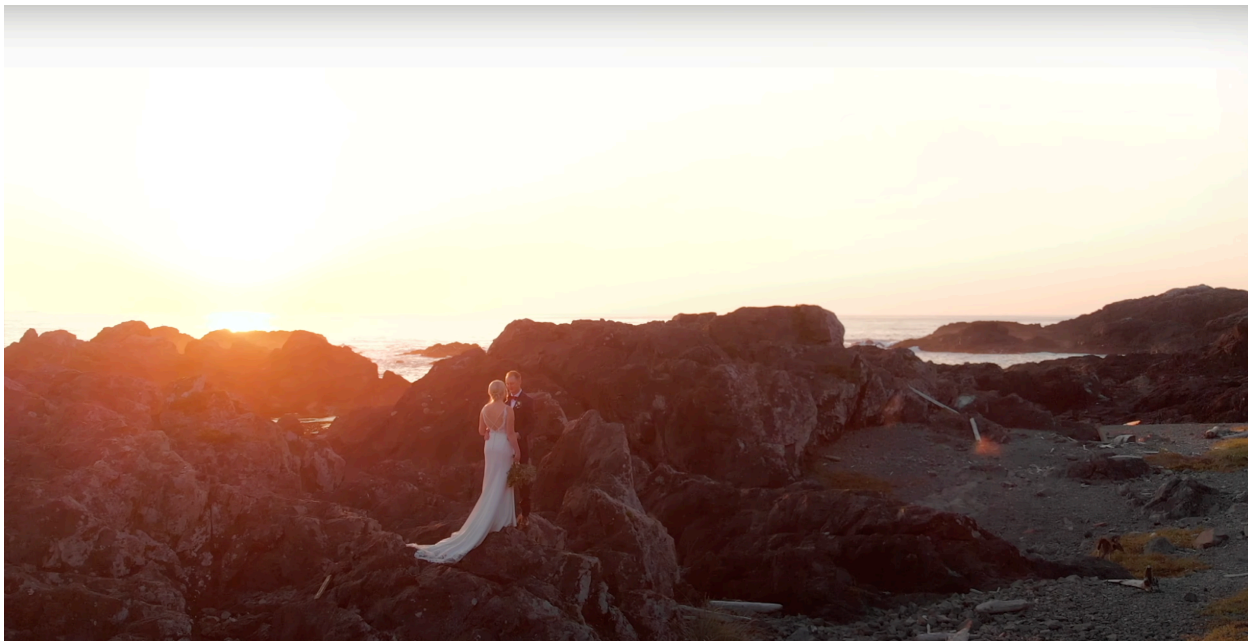
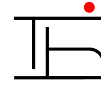

How it works!

1. Consultation

Once you have contacted us, we will setup a free video call or meet in person to go over a few details for your wedding day. We'll discuss how the overall process works with the video and what you can expect.

We will go over the simpler things such as location, time, date, and the package you've chosen. Then we will go into more details about your wedding day. We will talk about if there are any special moments taking place, cultural aspects, first dances, speeches, or anything else that may be taking place that is very important for you to have captured outside of the normal wedding events.

From here we will agree upon working together and a contract will be written up for you to read and sign, along with a down deposit fee to confirm your wedding date.



2. Planning

This is where we start the wedding day planning process. Once you have your wedding day schedule, we will go over each time window to make sure were both understanding of how the day will go. This usually takes place about around a month before the wedding day. We can discuss any potential changes if needed and then decide on music for your video.

We will send a non copyright site that we use for all of our videos and allow you to pick up to 5 songs that you'd like to possibly be featured in your video. We take your song choices into consideration and try to use as many as we can depending on the mood of the video and each event taking place. For example, you wouldn't want a high pace song being played during the ceremony portion of your video or a song with vocals being played over a small part of speeches.

You will have full access to email any questions or concerns you have once booked.



3. *Wedding Day*

It's your big day! Your wedding day has finally arrived and everything is ready to go! We want to make sure you only have your wedding day to focus on and making memories. We will be there on the agreed upon time to capture these moments for you so you have nothing to worry about. We'll capture your getting ready moments of both bride and groom along with the wedding parties.

During the ceremony we will attach a mic on the groom and place a backup audio device near by so we can ensure the best audio possible. We also set up a secondary camera that will record the entire ceremony so you can have the raw video and audio of that in a separate video if included in your package. We will include the speeches and first dances in a separate video alongside your main wedding video so you have those moments to look back on as well.



We will be sure to try and acknowledge any questions we have throughout the day to the wedding planner or whomever you have designated to do so.

The day will end with us letting you know that our agreed upon time is up before we leave, or, we will leave after a few songs of everyone dancing at the end of the night unless requested otherwise. We will be sure to let you know before our departure to make sure there's nothing else you may want before leaving.

4. *Editing Process*

In this stage we will gather all the footage we captured that day and start the editing process. We start by editing the entire video and then sending the first edit to you. You can then let us know of any small changes you'd like, excluding music. Once we/you have chosen the music, we put it in the video where we feel it is best suited and can not be changed once done as it would require us to re-edit the entire video. If you would like some shots changed, taken out, or switched around then we can make that happen.



Once we've received your changes, we will go ahead and start making those and then send it back to you for approval. If all is good, we will start the colouring process of the video and send it off to you along with the raw footage and audio of the ceremony, speeches, and first dances.

The time frame for delivery is between 5-8 weeks unless stated otherwise within the contract.

5. *Delivery*

Once the video is fully completed, a dropbox link will be sent via email. From there you can then click on the link, download the video, and save it to your device. The links do expire over time so we ask that the couple download and saves it as soon as possible. A file of the video will be kept on hand for a few months in case anything were to go wrong or you lost the video. The other video of the ceremony, speeches, and first dances will be sent in the same format. They may be separate links depending on how big the file size is.
